Oualifications

Alabama law requires the superintendent be chosen for general fitness and character; hold a degree from a recognized four-year college or university; and be knowledgeable in school administration. A master's degree is required but a doctorate is preferred. The successful candidate also must hold or be eligible for the appropriate certification to serve as a superintendent in Alabama.

Salary

The base salary for the position will be \$120,000-\$135,000 but will be negotiated based on qualifications and years of successful experience.

Fairfield City Schools is successfully implementing innovations in all academic areas. Elementary academic innovations include ACT CAMP Program (College Admissions Made Possible), Pre-AP Reading and Math Classes (Grades 5 and 6), and Academic Academies focusing on business/finance (C.J. Donald Elementary), engineering (Glen Oaks Elementary), and health sciences (Robinson Elementary).

The high school has a solid traditional program that is enhanced by advanced course offerings in all content areas: AP courses (grades 11 and 12), Pre-AP courses (grades 9 and 10), Honors Courses (grades 7 and 8), and dual enrollment programs. Also, the high school has ACT CAMP (College Admissions Made Possible), Credit Advancement, Golden Circle, dual enrollment and an excellent fine arts program. A partnership with Alabama Workforce Training Center allows high school students to achieve career readiness in 21 areas.

Technology initiatives totaling \$2.6 million have led to the upgrading of the infrastructure with wired and wireless access to all classrooms, new equipment and devices for staff and students, and 17 mobile computer labs. Fairfield City Schools utilizes online registration. In addition to an investment in technology initiatives, an investment of \$11 million dollars has added a Performing Arts Center and additional athletic facilities.

Located in western Jefferson County, Fairfield is part of the Birmingham metropolitan area. Its small size – only about 11,000 residents – gives it a decidedly small-town feel. But because of its proximity to Birmingham and the sprawling metro area, the city offers residents easy access to a wide array of cultural, social and religious activities. Among the nearby attractions are the Birmingham Civil Rights Institute, the McWane Science Center, Sloss Furnaces arts center and the Barber Vintage Motorsports Museum. In addition, the metro area has numerous recreational areas, including Red Mountain, which hosts outdoor concerts and other events; Ruffner Mountain Nature Preserve; Oak Mountain State Park; and the Birmingham Zoo.

Fairfield also is home to Miles College, a private, liberal arts historically black college with 1,700 students.
