About Us


The Autauga County School System's mission is to "provide excellent educational experiences for all students to be successful in life." As a premier school system, we take pride in providing quality education and rigorous academic standards for our students. Our schools aim to ensure college and career readiness through 16 career tech program areas, including dual enrollment agreements with regional and state colleges and universities.

We also offer access to additional educational opportunities such as the Maxwell Air Force Base Flexible Enrollment program, various after-school programs, and pre-K classes.

Autauga County Schools is ranked as the 43rd best school district in Alabama by Niche.com and the 37th most diverse. The system received a score of 88 B on the most recent edition of the state report card.

With 13 schools and over 8,900 students, our system maintains school safety as a top priority. All schools have received upgraded controlled entry systems, and nearly 500 security cameras have been installed throughout the district. The system has a strong relationship with the Autauga County Sheriffs' Department and the Prattville City Police Department, which provide school resource officers at schools throughout the county.





Autauga County is a friendly community located in central Alabama, north of Montgomery and 75 miles south of Birmingham. It is one of the fastest-growing counties in Alabama. The area is known for its abundance of natural beauty and recreational opportunities. The Alabama River forms the county's southern border and intersects with several creeks, including Autauga Creek for which the county is named. Autauga County is home to several outdoor attractions such as Robert Trent Jones Golf Trail at Capital Hill, the Roberta Case Pine Hill Preserve and Wilderness Park. The county's largest city, Prattville, offers convenient shopping and dining ranging from small local businesses to major chains.

The Autauga County Board of Education is seeking a leader with experience raising student achievement and building relationships to lead this growing school system.

Desired traits include:

- Ability to work with and generate support from the school board and buy-in from stakeholders and community partners

Qualifications

Alabama law requires the superintendent be chosen for general fitness and character and that he or she be knowledgeable in school administration. The successful applicant also should have or be eligible for the appropriate certification to serve as a superintendent in the State of Alabama and must hold at least a master's degree. In addition, he or she must have at least five years' experience in public school work and must have at least three years' experience as a teacher, principal, supervisor, superintendent, educational administrator or instructor in school administration during the last five years.

Salary

The base salary is \$145,000 and is negotiable based on qualifications and successful experience.

This search is being conducted by the Alabama Association of School Boards. All applications will be taken through Frontline, AASB's online application system, at bit.ly/AASBonlineapp.

If you are new to Frontline, you must first create a user account and password. Next, log in, complete the online profile, choose to apply for this search and upload a cover letter and resume. You also must have an official transcript sent directly to AASB from the institution that granted your highest degree.

If you have previously applied in an AASB-led search and already have a Frontline account, simply log in, choose to apply for this search, answer the questions specific to this search, update your profile and resume if needed and upload a cover letter. If your official transcript is not yet part of your online file, you may email SuperintendentSearch@AlabamaSchoolBoards.org to have AASB upload the official copy of your transcript; it is not necessary to have another copy sent.
